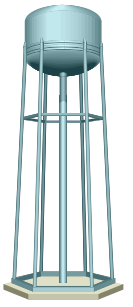

## INSTALLMENT AGREEMENT

Any fees normally assessed by the District on an unpaid balance shall apply to the declining unpaid balance.

Failure to fulfill the terms of this agreement shall institute the District's disconnection procedures as set forth in the Districts Service Policies.
